What is a safety standard for stationary batteries?

Safety standard for stationary batteries for energy storage applications,non-chemistry specificand includes electrochemical capacitor systems or hybrid electrochemical capacitor and battery systems. Includes requirements for unique technologies such as flow batteries and sodium beta (i.e.,sodium sulfur and sodium nickel chloride).

Are transportable energy storage systems included in this standard?

Transportable energy storage systems that are stationary during operation are included in this standard. This document does not cover BMSs for mobile applications such as electric vehicles; nor does it include operation in vehicle-to-grid applications.

What types of batteries can be used in a battery storage system?

Application of this standard includes: (1) Stationary battery energy storage system (BESS) and mobile BESS; (2) Carrier of BESS,including but not limited to lead acid battery,lithium-ion battery,flow battery,and sodium-sulfur battery; (3) BESS used in electric power systems (EPS).

What is a battery energy storage system (BMS)?

This document considers the BMS to be a functionally distinct component of a battery energy storage system (BESS) that includes active functions necessary to protect the battery from modes of operation that could impact its safety or longevity.

What if energy storage system and component standards are not identified?

Energy Storage System and Component Standards 2. If relevant testing standards are not identified, it is possible they are under development by an SDO by a third-party testing entity that plans to use them to conduct tests until a formal standard has been developed and approved by an SDO.
