How to import goods to the EU & to Germany?

Practice of Import. Every import of goods to the EU and to Germany is to be prepared in accordance with the customs regulations. The importer must apply for an EORI Number on the electronic customs portal of the customs authorities of the EU country of import. Then the customs tariff number must be legally researched and determined.

How is import regulated in the EU & Germany?

Legal summary. The import of goods to EU and Germany is widely regulated by the EU customs law and by the national customs, administrative, tax and criminal law of the countries of the EU.

Is Germany a customs territory?

Germany and all other EU Member States make up a customs territory with uniform customs regulations. Products imported into the EU are subject to EU-wide import regulations, customs tariffs, and customs procedures. This means customs duties are only levied once on import into the EU.

They are where goods can be introduced free of import duties, other charges (i.e. internal taxes) and commercial policy measures, until they are either assigned another approved customs procedure or re-exported. Goods may also undergo simple operations such as processing and re-packing.

In order to declare goods, you will need to submit a customs declaration. In most cases, this can be done electronically. Your carrier can usually take care of this for you, but you should check if this is possible before the goods are handed over to the carrier. If they can't, you should appoint your own customs broker to perform the clearance.

Some items are prohibited: you can't bring or import these into New Zealand. Some items are restricted: you will need approval to import or export these items.
