

Can energy storage flexibly participate in power system frequency regulation?

This paper proposes a control strategy for flexibly participating in power system frequency regulation using the energy storage of 5G base station. Firstly, the potential ability of energy storage in base station is analyzed from the structure and energy flow.

Can large-scale battery energy storage systems participate in system frequency regulation?

In the end, a control framework for large-scale battery energy storage systems jointly with thermal power units to participate in system frequency regulation is constructed, and the proposed frequency regulation strategy is studied and analyzed in the EPRI-36 node model.

What is the application of energy storage in power grid frequency regulation services?

The application of energy storage in power grid frequency regulation services is close to commercial operation. In recent years, electrochemical energy storage has developed quickly and its scale has grown rapidly. Battery energy storage is widely used in power generation, transmission, distribution and utilization of power system.

Does battery energy storage participate in system frequency regulation?

Since the battery energy storage does not participate in the system frequency regulation directly, the task of frequency regulation of conventional thermal power units is aggravated, which weakens the ability of system frequency regulation.

Do energy storage stations improve frequency stability?

With the rapid expansion of new energy, there is an urgent need to enhance the frequency stability of the power system. The energy storage (ES) stations make it possible effectively. However, the frequency regulation (FR) demand distribution ignores the influence caused by various resources with different characteristics in traditional strategies.

Can energy storage station and conventional generating units be jointly considered for frequency regulation?

In [13], the energy storage station and conventional generating units are jointly considered for the power system frequency regulation. The proposed strategy improves the effectiveness of frequency regulation and increases the utilization rate of conventional units.

Maintaining frequency stability is the primary prerequisite for the safe and stable operation of an isolated power system. The simple system structure and small total system capacity in the isolated power system may lead to the small rotational inertia of the system, which will make it difficult for traditional frequency regulation technology to respond quickly [4].
