Will Malaysia impose anti-dumping duty on solar glass imports?

Last month, the Ministry of Commerce & Industry's Directorate General of Trade Remedies (DGTR) recommended the tariff on Malaysian imports after Borosil Glass, India's only solar glass producer, filed an application for the imposition of an anti-dumping duty.

What is the new anti-dumping proceeding against Malaysian solar glass producers?

Now, a new anti-dumping proceeding against solar glass producers from Malaysia, is underway. The application was submitted by EU Prosun Glass. Martin Holzbecher, Vice President of the association, confirmed to pv magazine that "massively ramped up imports from Malaysia to the EU at dumping prices" are the basis upon which the motion was filed.

Will solar glass be produced in Sabah soon?

Does India impose anti-dumping duty on tempered solar glass?

The Indian government has imposed anti-dumping dutyon textured, toughened (tempered) solar glass originating in or exported from Malaysia and imported to India. The five-year duty - \$114.58/metric ton (Rs8,160) - will be applicable on solar glass from all Malaysian producers except China's Xinyi Solar Sdn.

Will EU Prosun glass impose anti-dumping and anti-subsidy tariffs on Malaysian solar glass producers? EU Prosun Glass filed a motion to impose anti-dumping and anti-subsidy tariffs against Malaysian solar glass producers, before the European Commission. Currently, nearly all producers across the entire value chain find themselves facing fierce competition.

India"s Ministry of Finance has imposed an anti-dumping duty on solar glass imports from China and Vietnam. The anti-dumping duties aim to protect the domestic solar glass industry from unfair pricing practices. The duty on Chinese imports ranges from \$673 to \$677 per metric tonne, while imports from Vietnam face a duty of \$565 per metric tonne.

The Solar Photovoltaic Glass Market size was valued at USD 22.35 Billion in 2023 and the total Solar Photovoltaic Glass revenue is expected to grow at a CAGR of 29.34% from 2024 to 2030, reaching nearly USD 135.33 Billion by 2030.
