Did Eni sign a US\$ 8billion gas production agreement with Libya?

Italian energy giant Eni signs a US\$8billion gas production agreement with Libya(Photo: NOC). The Chairman of Libya's National Oil Corporation (NOC), Farhat Bengdara, signed in Tripoli with the CEO of Eni, Claudio Descalzi, the development of an Exploration, Production and Sharing Agreement Development (EPSA) agreement.

What is'structures A&E' in Libya?

Tripoli (Libya), 28 January 2023 - Eni CEO, Claudio Descalzi, and the CEO of the National Oil Corporation of Libya (NOC), Farhat Bengdara, agreed today on the development of "Structures A&E", a strategic project aimed at increasing gas production to supply the Libyan domestic market as well as to ensure export to Europe.

What does ENI's New Energy deal mean for Libya?

For his part, Eni CEO Descalzi, stated: "This agreement will enable significant investments in the Libyan energy sector, contribute to local development and job creation while strengthening Eni's role as a leading operator within Libya".

How many gas fields are there in Libya?

It consists of the development of two gas fields,namely Structures "A" and "E",located in the contractual area D,offshore Libya. The combined gas production from the two structures will start in 2026 and reach a plateau of 750 million of standard gas cubic feet per day.

Who is the largest gas producer in Libya?

Eniis the leading international gas producer in Libya, with a share of 80% of the national production (1.6 bscfd in 2022). The company has been operating in Libya since 1959 and currently has a large portfolio of assets in exploration, production and development.
