



# Safety construction plan for energy storage projects

What is the energy storage safety strategic plan?

Under the Energy Storage Safety Strategic Plan, developed with the support of the Department of Energy's Office of Electricity Delivery and Energy Reliability Energy Storage Program by Pacific Northwest Laboratory and Sandia National Laboratories, an Energy Storage Safety initiative has been underway since July 2015.

What's new in energy storage safety?

Since the publication of the first Energy Storage Safety Strategic Plan in 2014, there have been introductions of new technologies, new use cases, and new codes, standards, regulations, and testing methods. Additionally, failures in deployed energy storage systems (ESS) have led to new emergency response best practices.

What are the energy storage operational safety guidelines?

In addition to NYSEERDA's BESS Guidebook, ESA issued the U.S. Energy Storage Operational Safety Guidelines in December 2019 to provide the BESS industry with a guide to current codes and standards applicable to BESS and provide additional guidelines to plan for and mitigate potential operational hazards.

What is an energy storage roadmap?

This roadmap provides necessary information to support owners, operators, and developers of energy storage in proactively designing, building, operating, and maintaining these systems to minimize fire risk and ensure the safety of the public, operators, and environment.

What are the three pillars of energy storage safety?

A framework is provided for evaluating issues in emerging electrochemical energy storage technologies. The report concludes with the identification of priorities for advancement of the three pillars of energy storage safety: 1) science-based safety validation, 2) incident preparedness and response, 3) codes and standards.

Can CSRS be applied to energy storage systems?

Until existing model codes and standards are updated or new ones are developed and then adopted, one seeking to deploy energy storage technologies or needing to verify the safety of an installation may be challenged in trying to apply currently implemented CSRs to an energy storage system (ESS).
