

Why are US tariffs on solar panels coming to Southeast Asia?

The tariffs unveiled Monday vary widely depending on the company and country but are broadly higher than the preliminary duties announced late last year. Combined dumping and countervailing duties on Jinko Solar products from Malaysia were among the lowest at 41.56%.

At first, solar export tariffs were created in response to the government launching the Smart Export Guarantee (SEG) in 2020.. This initiative compels energy suppliers with 150,000 customers or more to pay households for any renewable energy - including solar electricity - ...
