What is the value of imported products in Zimbabwe?

Year over year, the value of Zimbabwean imports grew by 6.9% compared to \$4.8 billionfor 2022. At the more detailed 4-digit Harmonized Tariff System code level, Zimbabwe's top 5 most valuable imported products are processed petroleum oils, trucks, nitrogenous fertilizers, soya-bean oil and cars.

How much did Zimbabwe import in 2023?

The Republic of Zimbabwe imported US\$9.2 billionworth of products from international suppliers in 2023. That dollar total reflects a 91.9% acceleration from \$8.6 billion in imports 5 years earlier during 2019. Year over year, the value of Zimbabwean imports grew by 6.9% compared to \$4.8 billion for 2022.

Where do Zimbabwe's imports come from?

Trade partners in Asiasupplied 33.9% of Zimbabwe's total imports while another 7.6% worth of goods originated from European nations. Smaller percentages came from Latin America (6.2%) excluding Mexico but including the Caribbean, North America (0.7%), and Oceania (0.1%) led by Australia and New Zealand.

What are Zimbabwean imports & exports in 2022 & 2023?

Among these import subcategories, Zimbabwean purchases of temperature-change machines (up 180.5%), air or vacuum pumps (up 54.8%) then spray and other dispersing mechanical appliances (up 16.2%) grew at the fastest pace from 2022 to 2023.

Which products did Zimbabwean importers spend the most on in 2023?

In 2023, Zimbabwean importers spent the most on the following 10 subcategories of mineral fuels-related products. Among these import subcategories, Zimbabwean purchases of crude oil(up 268.7%), petroleum oil residues (up 103.6%) then high temperature distilled coal tar oils (up 83.6%) grew at the fastest pace from 2022 to 2023.

What percentage of Zimbabwe's imports come from African countries?

From a continental perspective,more than half (51.5%)of Zimbabwe's total imports by value in 2023 was purchased from fellow African countries. Trade partners in Asia supplied 33.9% of Zimbabwe's total imports while another 7.6% worth of goods originated from European nations.

Customs Duty is levied on imported goods in terms of the Customs and Excise Act [Chapter 23:02], whilst Excise Duty is levied on certain locally manufactured goods, and other imported goods falling under the Excise Tariff even if they are entered under Trade Agreements. There are three different types of payments upon importation of goods into Zimbabwe: import duty, surtax, and value added tax (VAT) as described in the Harmonized System Tariffs Handbook and other relevant legislation. Most imported goods are subject to surtax and VAT of 15 percent.
