How to find tariff rates in Mozambique?

The tariff rates for import and export goods can be queried through the Mozambique Customs Tariff (Pauta Aduaneira de Servico de Mozambique). [Customs Service Fee] Regardless of whether the goods are duty-free or zero tariff, the customs will charge a customs service fee of 1% of the value of the goods.

Which goods are subject to export tax in Mozambique?

Cashew nuts, precious metals, gemstones, mineral products, and narcotic drugs are subject to export tax. The tariff rates for import and export goods can be queried through the Mozambique Customs Tariff (Pauta Aduaneira de Servico de Mozambique).

Mozambique,Exports of goods and services as percentage of GDP is 31.38 %. Tariffs imposed by Mozambique in 2021 are below. The maximum rate of tariff in percentage on any product is 20. The simple average tariff across all products is 8.84. The trade weighted average tariff is 4.19.

What percentage of Mozambique's World Imports are intra-Africa imports?

For 2020,33%of Mozambique's world imports were intra-Africa imports. Mozambique's intra-Africa imports are mainly from the other SADC member states. Between 2019 and 2020,intra-Africa imports declined by 13%. Electrical energy is the main import product,accounting for 9% of Mozambique's intra-Africa imports.
