Should China scrap anti-dumping and Countervailing Measures on solar glass imports?

The European Commission has concluded that there are no compelling reasonsto scrap definitive countervailing and anti-dumping measures on solar glass imports from China. Currently,the anti-subsidy duties range from 3.2% to 17.1%, while anti-dumping tariffs are between 17.5% and 75.4%.

What is the anti-dumping duty imposed on crystalline silicon photovoltaic modules?

Council Implementing Regulation (EU) No 1238/2013 of 2 December 2013 imposing a definitive anti-dumping duty and collecting definitively the provisional duty imposed on imports of crystalline silicon photovoltaic modules and key components (i.e. cells) originating in or consigned from the People's Republic of China (OJ 2013 L 325, p. 1).

Will India impose an anti-dumping duty on solar panels?

India has imposed an anti-dumping dutyon solar glass imports from China and Vietnam. While the intention was to protect domestic producers and support Indian manufacturing, developers worry this will escalate solar panel prices, impacting financial viability and project timelines.

What are the anti-subsidy and anti-dumping duties on solar glass?

Currently, the anti-subsidy duties range from 3.2% to 17.1%, while anti-dumping tariffs are between 17.5% and 75.4%. The European Commission has decided to maintain anti-subsidy and anti-dumping duties, first introduced in May 2014, on solar glass imported from China. The new measures went into force on July 23.

Why did the EU impose anti-dumping duties on Chinese solar panels?

On 2 December 2013,the Council imposed anti-dumping duties in respect of imports of solar panels and key components originating in and consigned from China.1 An investigation carried out by the Commission in 2012 and 2013 had revealed that Chinese solar panels were being sold in Europe at well below their normal market value.

Does China impose a countervailing duty on crystalline silicon photovoltaic modules?

Council Implementing Regulation (EU) No 1239/2013 of 2 December 2013 imposing a definitive countervailing duty on imports of crystalline silicon photovoltaic modules and key components (i.e. cells) originating in or consigned from the People's Republic of China (OJ 2013 L 325, p. 66).

The product is known by various names including solar glass, low iron solar glass, solar photovoltaic glass and high transmission photovoltaic glass. It is used as a component in solar modules and solar thermal applications. A similar product from China is also subject to the ongoing anti-dumping investigation.

On February 17, 2023, India issued an official notification regarding the initiation of an anti-dumping investigation on certain solar panel products from China and Vietnam.. The Directorate General of Trade Remedies (DGTR) is investigating allegations of dumping of patterned and uncoated toughened glass (solar panel or solar photovoltaic glass from China and Vietnam).

In comparison, Zhejiang Hehe Photovoltaic Glass Technology will have to pay the highest duty of 17.1%. A tariff of 12.8% has been set for Zhejiang Jiafu Glass, Flat Solar Glass Group, and Shanghai Flat Glass. The new measures came in force on July 23, 2020. The Commission had initiated a review of the duties applicable to the import of solar glass.

Many Malaysian importers were not spared. However, India says it has enough PV glass capacity to meet the needs of its own PV manufacturers. In April, India announced an anti-dumping duty on EVA sheets imported from China, Malaysia, Saudi Arabia and Thailand for five years to protect domestic companies from cheap imports.
